#### 1. Introduction:

The 2023 edition of Rwanda Internet Governance Forum (RWIGF) was held on the 3<sup>rd</sup> August 2023 at Park Inn by Radisson Hotel, Kigali-Rwanda. The main objective of this year's forum was to optimize the opportunity for open and inclusive dialogue on Internet Governance and related matters while creating opportunities for shared best practices and experiences; identifying emerging issues and bringing to attention relevant bodies and the general public on pertinent and legitimate governance matters while contributing to capacity building in the Internet ecosystem. This multistakeholder Forum brought together the government, private sector, civil society, media, the technical and academic community for a discussion on the Internet governance matters.

The forum was graced by the Minister of the Ministry of ICT & Innovation, Hon. Paula Ingabire as the Guest of honor, Keynote speaker, Dr. Ozonnia Ojielo the UN Resident Coordinator to Rwanda, senior officials and other distinguished representatives from local and international entities who shared their experiences and expertise on discussed matters through speeches, panels and presentations.

Serving into the global philosophy of Internet governance, the forum mainstreamed thought-process on the four (4) main discussion topics;

- 1. Internet Access, Affordability and Digital Services and Empowerment:
- 2. Emerging technologies, Online safety and security:
- 3. Al Policy for Rwanda
- 4. Data Protection Law in Rwanda.

3. Opening Remarks:

4. Keynotes Address;



Dr. Ozonnia Ojielo, the UN Resident Coordinator to Rwanda

While addressing the RW-IGF2023 Participants through his recorded message, Dr. Ozonnia Ojielo, the UN Resident Coordinator in Rwanda started his keynote speech by thanking the Hon. - Internet has become integral part of our daily lives transcending geographical boundaries, connecting individuals, communities and nations in unprecedented ways.

- The Internet we want must prioritize inclusivity and accessibility of every Rwandan to partake the benefits it offers.
- We must come together to bridge the digital divide leaving no one behind so that everyone can harness the vast potential of the digital world.
- We must strive to promote digital literacy, skills development, empowering Rwandans with Knowledge and expertise to navigate digital landscape confidently.
- Rwanda has achieved 2 profound achievements of having AI Policy and Data
  Protection Law in place which is a testimony of its commitment to advancing
  technology, innovation and safeguarding the rights of its citizens. Showing Rwanda's
  readiness to embrace the fourth industrial revolution.
- We must come together around Global Digital Compact to avoid fragmentation, safeguard human rights and ensure technology is force for human wellbeing, solidarity and progress.



Hon. Paula INGABIRE, the Minister of Ministry of ICT & Innovation

While addressing the RW-IGF2023 participants, Hon. Paula started her Keynote Speech by thanking and applauding the organizing committee and the partners for making the Rwanda IGF 2023 edition happen. She highlighted that the theme "The We Want- Empowering All



People" voices for the citizens and argued all participants in the room to wear the shoes of the citizens and find lasting resolutions from the forum. Speaking from a government' perspective;

- Internet Governance Forum is key and important forum that brings together different partners and players to work together and collaborate to not only discuss Internet pertinent issues but also find solutions together.
- The Internet we want for our citizens is the Internet that is the basic right to everyone.
- The Internet must be accessible and affordable to citizens, must be relevant to them in terms of content, and must be trusted and secured.
- Connectivity itself is not sufficient and that is why we have to ensure that our citizens have the right and relevant digital literacy skills, how we are promoting the penetration of devices.
- Part of Government's efforts beyond having a last mile connectivity is ensuring that
  most of our citizens have smart devices but also make sure that the content and
  applications built create right value proportion to the citizens.
- The Minister's call to action to Telecom Operators, ISPs, Policy makers, regulators, content and applications creators and device companies is to ensure that these important elements of Internet; Accessibility, Affordability, relevance, Trust and Security are always considered when delivering the Internet.
- The government urges players not to neglect Governance of Data and Safeguarding of privacy. Data plays a critical role in ensuring that we have a relevant and meaningful connectivity.
- With the existence of Data Protection Office (DPO), we should ensure that Data is used in innovation sharing but in a manner that enhances information accuracy.
- The biggest call for all of us is to put ourselves in the shoes of our citizens and make sure we provide a relevant and meaningful Internet we want for our people.
- The government is highly committed to ensuring that all Rwandans have access to Internet, but also affordable and relevant Internet.

#### 5. Panel Discussions, Presentations and Key Deliberations:

The Forum had two (2) main panels with experts to discuss on the two (2) main thematic tracks namely; (1) Internet Access, Affordability, Digital Services and Empowerment, (2) Data Protection Law in Rwanda; and also had two (2) main presentations delivered by experts in the industry, namely; (1) Emerging technologies, Online Safety & Security and (2) Al Policy for Rwanda.

Key deliberations were recorded after discussions;



#### 5.1 Internet Access, Affordability, and Digital Services Empowerment:



#### The Panel discussing Internet Access, Affordability, and Digital Services Empowerment:

The panel had the presentation of the Regulator-RURA, Internet Service Provider- Liquid Rwanda, Internet Society & Digital Public Services-IREMBO. The Panel addressed issues related to making the internet accessible to all Rwandans, regardless of their location or economic status. Speakers focused on strategies to improve internet infrastructure, reduce the cost of connectivity, and promote the availability of digital services. The empowerment aspect was discussed and resolved that Internet access will uplift individuals and communities by providing educational, economic, and social opportunities.

5.2 Emerging Technologies, Online Safety, and Security:




Mrs. Josephine NYIRANZEYIMANA, GCIO- Rwanda Information Society Authority Mrs. Josephine's Presentation explored 5 New Emerging Technologies including;



- 1. Quantum Computing
- 2. Metaverse
- 3. Brain Computer Interface (BCIs)
- 4. Synthetic Biology
- 5. Advanced Robotics and Automation

She explained the risks associated with Emerging Technologies (ET), Tips for online safety, Cyber-security measures and Child online safety. After her presentation, discussions centered around harnessing these technologies for societal benefits while addressing concerns about online safety and cybersecurity. The forum argued the relevant bodies to prioritize data privacy, combating cyber threats, and ensuring responsible and ethical use of technology.

However much Emerging technologies offer exciting possibilities, but they also come with risks. Therefore, the forum argued to prioritize online safety and cyber security to protect ourselves and others in this digital era".





Mr. Joris CYIZERE, Ag. MD, Centre for the Fourth Industrial Revolution Rwanda

Mr. Joris' presentation delved into Rwanda's Artificial intelligence (AI) policy and why it is important. The AI policy has five national objectives; Positioning Rwanda as Africa's AI lab, Creating an Open Data Ecosystem as an enabler of the AI Revolution, Driving Public Sector Transformation to Fuel AI Adoption, Accelerating Responsible AI Adoption in the Private Sector and Building AI Literacy and 21st Century Skills.

The forum's resolved on the following;

- The Rwandan community should leverage on AI for economic growth, social development, and innovation.
- All adoption should be accelerated by enabling the rapid growth of Rwanda's All ecosystem, fostering the adoption of All in high growth sectors, and scaling public and private sector investment in Al.



• The efforts to raise public awareness on AI, the understanding of AI policy and its benefits should be put in place.

#### 5.4 Data Protection Law in Rwanda:



#### The Panel discussing Data Protection law in Rwanda

The panel had the presentation of Data Protection Office-NCSA, Law enforcement office-Rwanda Investigation Bureau, Private sector & Customers' Rights Association. The discussions revolved around personal data privacy and protection regulations within Rwanda. Conversations touched on the importance of safeguarding individuals' personal information, the rights of data subjects, responsibilities of organizations handling personal data, the categories of individuals/organizations handling personal data (Data controllers and Data Processors), mechanisms for enforcement, and strategies for public awareness of the existing data protection law and how the law can work for the public. The forum argued the Data Protection Office (DPO) to ensure that the public is aware and the law is implemented in the benefit of the owner of the data (Data subjects).
